Facebook Group Guidelines

Newham Primary School Community Facebook group is endorsed by Newham Primary School to allow our community to keep up to date with activities, support and social connections through the use of an easily accessible online environment. It does not replace the school communication app uEducateUs.

1. Users of the **NPS Community** Facebook group must be respectful of and adhere to the school's values and School Community Code of Conduct.
2. Newham PS encourages the school community to share positive news, upcoming events (for example, Newham Plant Sale, Newham & District Landcare Group, Newham Mechanics Institute Events, not business related events) and general enquiries using the Facebook page (**NPS Community**). All posts will be approved by moderators, usually within 24 hours.
3. **NPS Community** will not support negative posts or comments, and we do not permit photos of students included in posts.
4. Issues involving personal relationships with students or staff must not be raised on this Facebook page. These should be raised privately or in accordance with the school's Addressing Community Concerns & Complaints policy.
5. **NPS Community** will not accept posts that promote businesses unless a prior arrangement has been approved by the school.
6. Community information that doesn't directly affect the school should not be posted on the NPS Community newsfeed. We encourage students and parents to consider a more suitable platform such as a local Buy Swap Sell Facebook Group. For example, warning parents of a theft from cars during school drop off or adverse road conditions on a school route is welcome, but a Buy Swap Sell site is more suitable and has a more far-reaching audience for general information about animal welfare or the best fence to keep cattle in.
7. Members will be able to like and comment on posts. All posted comments will be reviewed by the moderators.
8. **NPS Community** is a closed Facebook group. Messages will only be able to be viewed by members. All members will be required to be approved by the page moderators. All members must have a direct personal connection to Newham Primary School and be identified by their real name.
9. The moderators retain the rights to take away the membership of this group from any member who contravenes these acceptable use guidelines. Two FB group moderators and the Principal will discuss any posts/comments contravening these guidelines which will result in 1. direct contact with the person posting/commenting, 2. 'time out' from the group for a certain period or 3. removal from the group with no further membership allowed in the future.

10. Members will be removed once their connection with the school ceases i.e. they no longer have students enrolled at or a direct involvement with the school.
11. Following Facebook's terms and conditions, **NPS Community** does not endorse the creation of a Facebook account by children under 13 years of age and will not accept children as members.
12. **NPS Community** Facebook page operates under the Commonwealth Telecommunications Act and Facebook's Statement of Rights and Responsibilities. We respect and adhere to the NPS ICT User Agreement.
